

**THE FAIRWAYS HOMEOWNERS ASSOCIATION
POOL PARTY GUIDELINES**

1. Pool “parties” are allowed, but each event must follow the posted guest policy allowing only 5 guests per card.
2. Advanced booking must be made with the Community Association Manager, at (770)575-0943 or info@sixesmanagement.com.
3. It is recommended to have a two (2) hour maximum for all parties.
4. The lifeguard on duty MUST sign off on this form below confirming that your area was properly cleaned up. Signed form must be returned to the Community Association Manager.
5. All Fairways Pool Rules must be followed or you will be asked to leave the pool area.
6. Any damage to property, pool, restrooms, etc... will be paid for by the signed homeowner.
7. Use of the Clubhouse requires a separate rental agreement.
8. All clean-up will be responsibility of the signed homeowner.
9. Parties of 12 or more will be required to hire an additional lifeguard at the rate of \$25.00 an hour. Guards may be booked through Swim Atlanta at <https://www.atlanta-pmg.com/pool-parties>
10. The signed homeowner will be responsible for any attendees or unauthorized guests. Only owners in good standing with the Association will be allowed to book parties. If there is an outstanding balance on your Association account, you will not be allowed to host a party.
11. Fines may be applied to your Association account should the rules not be followed or your area is not cleaned up.
12. NO UNREGISTERED PARTIES WILL BE ALLOWED, AND ANY OWNER HOSTING AN UNAUTHORIZED PARTY WILL BE SUBJECT TO A FINE AND/OR SUSPENSION FROM THE FAIRWAYS HOA AMENITY AREAS.
